- 15<sup>th</sup> January DFE requested OFQUAL to undertake a consultation to inform how GSCE grades will be set
- 25<sup>th</sup> February DFE presented findings of consultation and next steps
- DFE to provide detailed guidance to schools by the end of the spring term.

#### **Assessment & Evidence**

#### Teachers will:



- assess students' performance only on what content has been delivered.
- use evidence from throughout the course
- determine the grades as late as possible in the academic year.
- use a broad range of evidence.
- allow students to continue to work on their non-exam assessment (NEA).

Overall, it will be no easier or harder for a student to achieve a particular grade this year compared with previous years.

Results will be based on completed and future work, so keep doing your best



- teachers will have a good understanding of a students' performance
- teachers will refine their understanding through continued teaching and assessment
- Students will take additional mocks
- Teachers will use classwork
- Teachers will use ongoing assessed tasks
- Teachers will use the exam board provided materials

### **Support Materials**

Exam boards will provide a package of support which will include;



- question banks (based on past questions and some previously unpublished material
- mark schemes
- data about how students typically performed in individual questions
- exemplar materials
- advice for teachers about content coverage
- topic selection
- marking
- making grading judgements

Teachers will be able to use the support materials immediately following publication and until the deadline for the submission of grades.

#### Evidence we already have

- Autumn term mocks will inform our TAGs but will NOT be the sole piece of evidence.
- Classwork
- Non-exam assessment (NEA)
- Portfolio work
- End-of-unit assessments



This is what students knew before lockdown

We recognise that students had significant gaps due to lockdown 1 and that some questions were based on content not yet taught or content that will not be taught.

# Continued teaching & assessment



- Curriculum modification of remaining time
- Mock examinations after the Easter holidays
- Modifications to papers / grade boundaries so that assessment is based on what has been taught
- Throughout the summer term students will be provided with exam board support materials so that evidence can be collected to demonstrate if additional progress has been made.
- Further assessments of NEAs and portfolios

## Awarding & Recording Grades A+



- Grades based on work/assessments teachers have seen
- Grades must reflect the whole course
- Students who did not engage during lockdown or when they return could see their November mock grade lowered

## **Quality Assurance Checking**



- departments will work together to moderate samples of students' work and standardise their approach
- random samples of work will be requested by SLT and compared with other students' work
- Exam boards will put in place arrangements for external QA to check each centre's internal QA process
- In a sample of centres, reviews will be made of the evidence for one or more subjects
- Sampling should be both random and risk-based
- Exam boards will process the grades submitted by centres only after completing, and being satisfied with, any external QA
- Exam boards will require centres to submit a declaration by the head of centre

#### **Appeals & Results**



- Students will be able to appeal their grade
- Requests can be made to the centre to check whether an administrative or procedural error had been made
- Where a centre does not believe an error has been made, a student can ask the centre to appeal to the exam board on their behalf
- The centre will submit the student's appeal to the exam board and provide the evidence on which its judgement had been made
- The exam board will also check that the centre had followed its own process
